In an attempt to confuse the victim or to cause them to doubt their own logic and reasoning, stalkers might rearrange or steal personal items in the work place or home.

If for whatever reason my texting is disturbing you because of your notifications mute my notifications for this time period so that they are not disturbing you That is a level of standards that is applies because it is now 7:35 p.m. and I'm down sitting at 35% charge and I want to continue my introduction to you. This is about rights or the lack thereof. And what is called a new right in the document called legal capacity. And what is called disability inclusion and who is responsible for that? I will get into

that in a minute. I am not going to specifically assign a Time window for me to text you. No you're going to sign a time window to read my text on a timely manner. and that is what I'm expecting. Did you know that is a given and a right universal declaration of right human right that was enacted in 1948 I do believe? --- I have rights.

Those rights are being intentionally violated. I can come here is beyond the reasonable doubt. Court level assigned testimonial proof. What right am I making sure I have with you here now?

Article 19 the declaration of human Rights that applies to the United Nations and international law that we as the United States are a member of. There's all citizens of the United States of America have this right under international law. Article 19 Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers.

There is no time that that right is restricted or to be interfered with. That's a clarification. The freedom of opinion is very important here. Even though the opinion May sign a light in a negative way upon you or control or upon you as a collective you all as a role is irregardless it is my right of opinion. And your reaction to it should remain neutral. Taking action because it passed a negative light upon you individually or you as a collective role is irregardless of this right you can't deny me this right. This was enacted in late 1940s after the reckoning of a world war that we had known as world war II. Call me smart in a good way but then again I took it in in a negative light at first and I'm so not sure if I was right first time or something quite corrected or what's standing I have currently with all of what I have to say with the right as my opinion to have my and to hold it sound and faithfully sane apart from the insanity that has happened to me and I have documented. Passion draws upon the fashion that an artificial intelligence

Known as grammarly gave me the score. I passionate to try to save my life.

I sent this to Elizabeth and now I have sent this to you. I would say that is a new score. I would say there is going higher. Gov documents are public. Not only that but it was specifically the leaking of the document I'm trying to share of above here that I think to earlier she said she could not link to. That's not true she lied to me. This led a few weeks earlier to events of a blood room in a motel room. That's not getting to the visuals of that yet. When I was tasered out of the room, they sent me to mental evaluation at Arrowhead which is a county resource and has county medical equipment stations. The exact counting system that is in Darcy's desk or whatever she uses the same exact system. Day of course had a watcher over me to make sure I didn't get to harm myself. I was in the medical facility area when she asked me. Did I want to watch a movie? I wasn't sure what she meant at the time. But I answered her yes I want to watch a movie.

Barring any difficulty in establishing a repurposing of actual medical equipment sitting right there at the desk you know in the town are there that I was in cubicle. She set aside the screen and logged into her login and opened YouTube. And started a movie. Darcy said she couldn't access the internet. Darcy being the manager of the ccrt staff that I was trying to get involved with resources on getting help. I seem to still having problem getting that committed help. And I wonder if you're going to respond or if you're going to try to terminate my services and cut me to the curb and thow me out in the street. I'm already in the street and can't go much lower.. A death is pending. That's I guess lower. This is extreme Ben. I hope indeed you are following. Can you confirm your following?

I said to Google my name. My full name. You might find that interesting. Also might find if you find out who I am and all of this I own a school project online. It is a valid School assignment. On property sites, real estate for sale sites, there's like a feature called near by schools. My entry appears for the area. Not only that. The entry it's part of my USPS business profile registration. That is because it is a valid option that is available as a mailing address. And further This was wonderful to see..

One day coming home on a lyft. That is a service a similar to Uber, I was upgraded to the free to luxury car status. Not only was it electric car status but it was a Tesla . This has happened to me twice actually. Once my mom was in with me and I was coming back from a doctor's appointment. And it got upgraded luxury and a Tesla arrived and picked us up. When this happened to me by myself the interior of the Tesla was strange enough to see but was basically what it was

Instead of a small screen for the navigator. A very large installed in that car.. that is because the Tesla itself can drive itself and there's no reason to have a small screen if all the occupants want to watch a movie.

When coming up to the address of my then House of residence, which is the restaurant address of a school as I try to tell you. Priceless to the experience. I was telling the driver of course. That is the house that my mom threatened my life but guess this is what it says as the location within the navigator of a car known as a Tesla that can drive itself. Appearing attached to the address that I was going to. Even though this has been a location that you can assign to Postmates and various other things on the internet this location marker is valid and the school is valid and I have the right to disability inclusion that is article 12 of the convention for the rights of persons with disabilities that was signed in 2009. DEPRIVATION OF RIGHTS UNDER COLOR OF LAW SUMMARY: Section 242 of Title 18 makes it a crime for a person acting under color of any law to willfully deprive a person of a right or privilege protected by the Constitution or laws of the United States. For the purpose of Section 242, acts under "color of law" include acts not only done by federal, state, or local officials within their lawful authority, but also acts done beyond the bounds of that official's lawful authority, if the acts are done while the official is purporting to or pretending to act in the performance of his/her official duties.

Persons acting under color of law within the meaning of this statute include police officers, prisons guards and other law enforcement officials, as well as judges, care providers in public health facilities, and others who are acting as public officials. It is not necessary that the crime be motivated by animus toward the race, color, religion, sex, handicap, familial status or national origin of the victim. The offense is punishable by a range of imprisonment up to a life term, or the death penalty, depending upon the circumstances of the crime, and the resulting injury, if any.

This is being conducted on a continuous non-addressible problem that continues to violate my rights over and over and over and over again and I cannot seem to get up and over it for you to all get a clue to how serious of a crime this is

TITLE 18, U.S.C., SECTION 242 Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, ... shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.

store inside the store told him to call the police they didn't call the police

This was a lyft from rite aid to Walmart to pick up my prescription then walk down where I was staying

his guy comes off of a bike and charge to harass me verbally accuse me of stealing and all of this got out of this bike and physically threatening

So I ran into the street ran over to the store they had an inconvenience of this happening they did not call the police apparently

So then I had to deal with no charge on my phone and having that the police were supposed to be there had to go outside

The man stalking me saw me came up and so I went back into the store

And when I came back into the store but man on the bike is there at the front of store wanting to see what is inside my bag and all this inside my back is my sleeping bag the one you gave me as a replacement which they already know this

So this carry on on and on for almost a half an hour

Eventually in this time. A second person join this stalker and they're two of them wanting to see what is in my bag

Now there's two of them the store will not call the police. So eventually I came in and I had the yellow blanket inside of the sleeping bag

I said what is inside the sleeping bag what is the inside the sleeping bag?

He wanted to know what he could identify was in my bag that he could say was his and the only thing it was in my bag that was definitely you know universally that he could have done that was the sleeping bag

But he could not identify what was in the sleeping bag

He scampered away saying that was not his the whole drama the whole drama the whole drama is pointless that I know that I am being stalked

Use social media tag (#OSINT) on YouTube and there are instruction videos that are called hacker apps and stalker apps

No kidding

So I eventually got myself up to where I was staying with sure and of course my aunt spray was missing and a couple things I have most of my stuff with me and I carrying on going back to the rite aid and I talked to the store manager and I had saw her after hours they called the police and they arrived I had another interview with the police the real police

Even though that's typical huh that's a typical experience of a homeless person huh

I'm not a person that is being just the same way as everybody else but you all treating me like this is the same category I am something different and I think this is absolutely insulting obvious that you all are allowing this to continue by not providing me services and especially not giving me access to a license with a license number and a name real person who has the title and the category of job responsibilities of a licensed social worker as immediately as quickly as humanly possible

And my doctor care needs to be straightened out and you are all guilty because you are all insane because you do not respond to my messages you obviously are ghosting me

4% battery charge

Messages are being delivered

So why am I not productive in response why is it the receiving end of this is completely oblivious to my messages

Do you get completely cardboard voicemail messages from from people that you can't understand who they are and why they're calling and perhaps a call back number?

I have that Captured with the help of Christina duarte the developer of that app.

She's got buzzing an interference noted by an actual CA human operator on the device buzzing and interference as I'm trying to play back my voicemail

I don't hear the buzzing and I hear the garbled messaging that the recording is but not beyond my own interpretation of what I am saying it could be just because it is my own voice and what I'm saying but the human operator cannot determine what I'm saying when I play back my voicemail before I send it. Busted busted busted

There is an interfering technology interfering elements in all of this. And it is Christina torti who has a inno caption support ticket. . Asking me about this ticket. Causing buzzing buzzing there is no buzzing on my end

I'm down to so little charge I can't even go over there and get the linnocaption I need an email address to put you into the referring of the support tickets

I know I know I know I know I need a social worker I got a masters of social work but not a licensed social worker when I went to the hospital the other day.

I have an intake at the salvation army on 10th Street that they have a caseworker there I'm not sure what her licensing is her name is Elizabeth and Elizabeth has a CO companion named Ben.

I have my SMS conversations with both of them as well as adult protective services actually archived on to the web.

The the introduction I began with Ben as of last night I put two spoken voice narrative.

I'm being stalked now I'm real time.

Tina for something I need a place to stay that is secure.. looks like the witness protection program.

Is my introduction to Ben in audio spoken voice. The XML file that is captured from my messenger vzm file, the body is extracted from a utility and this is the outcome. Not put the text file online yet but I have 76% of the audio in an OGG file to ben

Ben and Elizabeth are at the salvation army located at 10th Street. And they're basically not helping me. They are ghosting my conversation channel and they gave me a tent and a sleeping bag.

The majority of persons under attack report that stalkers frequently mirror the victim's behavior. Gang stalking might include mirroring physical gestures or verbal comments. Many victims relay that gang members often enter or leave properties and other locations at the same time as the target.

The man at the city council meeting mentions this in his case

Gang stalking targets might also experience hang-up calls or calls from wrong phone numbers throughout the day. Attackers may enter homes illegally or employ the assistance of the target's friends or family. In an attempt to confuse the victim or to cause them to doubt their own logic and reasoning, stalkers might rearrange or steal personal items in the work place or home.

The criminal offenses of stalkers may become more aggressive or violent against the target, family members or pets.
